

Electricity Invercargill Limited Notification of Line Charge Changes

Pursuant to the Electricity (Information Disclosure) Requirements 2004, Electricity Invercargill Limited hereby gives notice that the following line charges will apply for Installation Control Points (ICPs) as from 1 April 2009.

The new and existing line charges for the non individually assessed ICPs are shown below:

The line charges do not include metering charges and are GST exclusive.

The total annual line charge has been calculated based on the average consumption for that load group.

Electricity consumers should note that these are the line charges as charged to the electricity retailers. Individual electricity retailers will make their own decisions whether to adjust their retail prices to consumers to reflect any changes in the line charge.
